Petitioner, SANDRA LAM, Successor Trustee for the GORDON LAM AND SANDRA CHOW LAM RECOVABLE TRUST dated December 27, 2003, by and through her attorney of record. Julia S. Gold of the Law Offices of Julia S. Gold, P.C., filed her PETITION TO CONFIRM APPOINTMENT OF TRUSTEE, TO TAKE JURISDICTION OF TRUST AND FOR ORDER CONVEYING, TRANSFERRING OR DELIVERING PROPERTY TO TRUST PURSUANT TO NRS 164.033, which was set for hearing on June 3, 2019 at 1:30 p.m. No person appeared to contest the Petition. Upon proof duly made to the satisfaction of the Court, the Court finds as follows:

- All notices of the hearing have been duly given as required by law. 1.
- Gordon Lam (hereinafter referred to as the "Decedent"), died on March 7, 2018 a 2.. resident of San Francisco, California.
- Venue is proper in Douglas County, Nevada, pursuant to NRS 164.010 and California Probate Code section 850(a)(3), as the Decedent left real property located in Douglas County, Nevada.

- 4. The Decedent died testate. His original last Will and Testament, dated December 12, 2003, gives all of his personal effects to SANDRA LAM. The Decedent's Will is silent with respect to the Decedent's other assets and was executed prior to the date of the Trust.
- 5. There is a certain piece of real property commonly known as 88B Rubicon North, Lake Village (Glenbrook), Douglas County, Nevada ("Douglas County Property") which is titled in the name of GORDON LAM and SANDRA CHOW LAM, husband and wife, AS TENANTS IN COMMON.
- 6. It was the intent of the Settlors that the Douglas County Property was to be held in the name of the GORDON LAM AND SANDRA CHOW LAM REVOCABLE TRUST dated December 27, 2003 (hereafter sometimes referred to as the "Trust"), because on December 27, 2003, the same date that the Trust was executed, the Decedent and the Petitioner herein, executed a document titled "Schedule A- initial Funding of Trust Assets of the Gordon Lam and Sandra Lam Revocable Trust" (hereafter referred to as "Schedule 'A'". The Douglas County Property is specifically referenced in Schedule A; however, a deed was never prepared to effectuate the transfer of the Douglas County Property to the Trust.
- 7. SANDRA LAM, the Petitioner herein, is confirmed as the Trustee of the Trust and the Court takes jurisdiction of the Trust to transfer the Douglas County Property to the proper intended owner the Trust.
- 8. Pursuant to Article 7.14 of the Trust, all questions concerning the validity, interpretation, and administration of the trust are governed by the law of the State of California
- 9. California Probate Code 850(a)(3)(B) and NRS 164.033 (1)(b) and (5) provide that a trustee may petition the proper court to enter an order conveying, transferring or delivering property, if the trustee has a claim to real property and another holds title to or is in possession of the property. Sandra Lam, the Successor Trustee of the Trust has a valid claim to the Douglas County Property, which is titled 50% in the name of Gordon Lam as tenants in common with Sandra Lam.
