(c) A facsimile counterpart signature to this Bill of Sale shall be acceptable and binding.

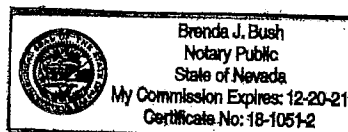
