5. The Judgment has been partially satisfied in the amount of \$.00 .


6. Post-Judgment interest has accrued at the legal interest rate, and the unpaid judgment balance is \$10,549.24.

7. The Judgment Debtor has no set-offs or counterclaims which would constitute payments or credits on the Judgment.



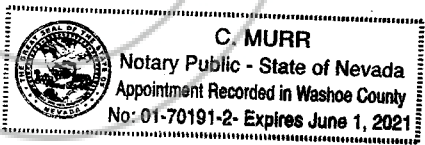


