**EXHIBIT "A"**  
**LEGAL DESCRIPTION**

Commencing at the intersection of the Northwesterly line of Parcel No. II as described in that certain Instrument recorded December 11, 1965 in Book 28 of Official Records at page 284, and of the Southwesterly line of McFaul Way as shown on that certain map of Round Hill Village Unit No. 1, filed in the office of the County Recorder on April 21, 1965 under Document No. 27741; said point being also described as being South 47°13'00" West 30 feet and North 42°47'00" West 221.52 feet from the Southerly terminus of that certain course in McFaul Way shown as North 42°47'00" West 265.81 feet on said map; thence North 42°47'00" West 44.29 feet; thence Northwesterly around a curve to the right following the Westerly right-of-way line of McFaul Way on a radius of 245 feet through a central angle of 28°56'29" for an arc distance of 123.76 feet to a point of reverse curvature on said right of way line and the most Easterly corner of this parcel; the True Point of Commencement; thence South 32°25'55" West 87.41 feet to the most Southerly corner of this parcel; thence North 63°16' West 62 feet; thence North 26°44' East 93.26 feet to a point on the Southerly right-of-way line a distance of 8.60 feet; thence Southeasterly along said right-of-way line along a curve to the right having a radius of 50 feet through a central angle of 79°47'24" for an arc distance of 69.63 feet to the True Point of Commencement.

19 Based upon the Verified Petition, the Notice of Private Sale, the Notice of Hearing To Confirm  
20 Sale, all of which were filed on 26 July 2019, all previous pleadings filed in this matter, together with  
21 the representations made in open Court at the hearing on the Petition, the Court hereby finds and orders  
22 as follows:

23 1. After the hearing on the Petition was called to order by the Court, the Court inquired  
24 of all those in the courtroom whether there was any person attending the hearing who wished to bid on  
25 the property. Three persons present wished to bid on the property. The Court accepted bids until the final  
26 bid was unopposed.

2. A Proof and Statement of Publication of the Notice of Private Sale; Notice of Hearing to Confirm Sale was filed on 27 August 2019. The publication of the Amended Notice of Private Sale; Notice of Hearing to Confirm Sale occurred on 15, 17 and 22 August 2019. Thus, the Court finds and concludes that the requirements of NRS 148.220 have been met by the Guardian.

3. The Douglas County property which is the subject of this Order, the sale of which is hereby confirmed, is commonly known as 480 McFaul Way, Zephyr Cove, Nevada, 89448. The property has been assigned Douglas County Assessor's Parcel No: 1318-15-702-001.

Escrow to close on or before 9/30/19.




