

The action sets forth the following claims and causes of action:

VERIFIED COMPLAINT FOR DAMAGES AND APPLICATION FOR A PRELIMINARY INJUNCTION.

The action is now pending in the above entitled Court, as more fully described in the Verified Complaint filed therein on February 12, 2019, which affects the Plaintiffs' rights to use a 30-foot private access easement across Parcel 4 owned by Defendant located in Gardnerville, Douglas County, Nevada 89460, APN 1220-31-001-021, and more particularly described as follows:
