

This Amendment #01 To a Contract for Services by an Independent Contractor is entered into this 29 day of 1/0vem her, 2018 by and between Douglas County, a political subdivision of the State of Nevada (the "County"), Richard M. Gutierrez and Rosa M. Gutierrez ("Assignor") and Rosie's Emerald Cleaning Services LLC, a Nevada Limited Liability Company ("Assignee"). The County, Assignor and Assignee are collectively referred to herein as the "Parties."
