7. The Judgment Debtors have no set-offs or counterclaims which would constitute payments or credits on the Judgment.



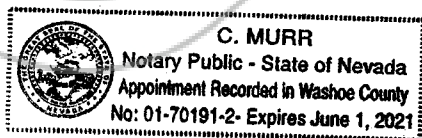
