4. The Nevada Medicaid Program provided payment for medical services for the care of Frances Stevens in the amount of TWENTY-FIVE THOUSAND EIGHT HUNDRED NINETY DOLLARS AND SIXTY-THREE CENTS (\$25,890.63) as of records dated October 2018.

- 5. The amount of the benefits paid may increase as Medicaid providers have until one year from the date of the death of Frances Stevens to bill Medicaid for services rendered.
- 6. The undivided estate of Frances Stevens included real property whose common address is 1442 Orchard Road, Gardnerville, Nevada 89410, situated in Douglas County, and whose legal description is as follows:

7. At the time of Ms. Stevens' death, she owned the property in joint tenancy with her spouse and appointed Guardian, Bayne Stevens, and had a fifty percent (50%) interest in the subject property. The Petitioner seeks to impose its lien only against the interest owned by Frances Stevens at the time of her death. Pursuant to state and federal law, the state may only recover on such a lien at a time when there is no surviving spouse, children under 21, blind and/or other disabled children of any age.

Additionally, the state must release its lien if the surviving spouse, child under 21, or disabled child seeks to engage in a bona fide sale or financial transaction involving the home.

7. The imposition of a lien upon the above-described real property of Frances Stevens, a deceased Medicaid recipient, by Nevada Medicaid is authorized and appropriate pursuant to Nevada Revised Statutes.

8. The imposition of a lien in the amount TWENTY-FIVE THOUSAND EIGHT HUNDRED NINETY DOLLARS AND SIXTY-THREE CENTS (\$25,890.63) which represents the amount of assistance paid on behalf of Frances Stevens, a Medicaid recipient, by Nevada Medicaid is authorized and appropriate pursuant to Nevada Revised Statutes.

THEREFORE, based upon the foregoing, IT IS HEREBY ORDERED, ADJUDGED AND DECREED AS FOLLOWS:

A lien, on behalf of the NEVADA STATE DIVISION OF HEALTH CARE FINANCING AND POLICY (Nevada Medicaid), in the amount of **TWENTY-FIVE THOUSAND EIGHT HUNDRED NINETY DOLLARS AND SIXTY-THREE CENTS (\$25,890.63)** is hereby imposed against the real property of the undivided estate of Frances Stevens of which she was fifty percent (50%) owner of the property commonly known as 1442 Orchard Road, Gardnerville, Nevada 89410, situated in Douglas County, and whose legal description is as follows:
