**NOTICE OF DEFAULT AND ELECTION TO SELL UNDER  
CLAIM OF LIEN FOR DELINQUENT ASSESSMENTS

**IMPORTANT NOTICE: IF YOUR PROPERTY IS IN FORECLOSURE BECAUSE YOU ARE  
BEHIND IN YOUR PAYMENTS, IT MAY BE SOLD WITHOUT ANY COURT ACTION,** and

you may have the legal right to bring your account in good standing by paying all of your past due payments plus permitted costs and expenses within the time permitted by law for reinstatement of your account. No sale date may be set within **sixty (60) days** from the date of recordation of this Notice of Default and Election to Sell Under Claim of Lien for Delinquent Assessments and the mailing of a copy of this Notice, (which date of recordation appears on this notice).

This amount is \$<See Exhibit "A">, (includes Foreclosure Costs) as of January 3, 2020 and will increase until your account becomes current.

While your property is in foreclosure, you still must pay other obligations (such as taxes) required by the Declaration of Covenants, Conditions and Restrictions. If you fail to make future assessment payments, pay taxes on the property, or pay other obligations as required in the Declaration of Covenants, Conditions and Restrictions, the Association may insist that you do so in order to reinstate your account in good standing. 

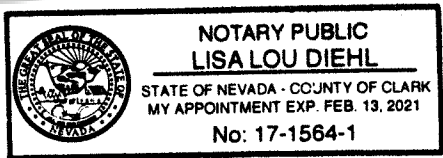
