WHEREAS, CEANNCADHA L.L.C., a Nevada limited liability company, executed a Promissory Note payable to the order of KEVIN C. MOERDICK and SUE K. 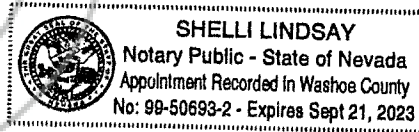
