16 This matter came regularly for trial on February 5 through 7, 2020, and was concluded and  
17 submitted to the Court sitting without a jury. James R. Hales, Esq. appeared as counsel for plaintiff,  
18 Horst Gerich. Michael S. Rowe, Esq. appeared as counsel for defendants, Jerry Vandenberg and Nancy  
19 Vandenberg. The Court having heard and considered the testimony and proof offered by the respective  
20 parties, and arguments of the respective parties, and the cause having been submitted to the Court for  
21 decision, the Court being fully advised in the premises hereby enters Judgment.

22 IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that the plaintiff have and recover  
23 of defendants the sum of \$52,452.88 as compensatory damages and \$55,000.00 as punitive damages and  
24 costs in the amount of \$2,120.40 for a total judgment of \$109,573.28.

25 Interest shall run on the Judgment amount at the Nevada statutory rate as provided for in NRS  
26 99.040(1). The interest due from the date of filing the complaint through February 29, 2020, is  
27 \$10,022.20 computed as follows:






