WHEREAS, the former property developers created a non-profit corporation entitled COTTONWOOD MEADOWS SUBDIVISION HOMEOWNERS ASSOCIATION to manage the Subdivision's irrigation system and to establish a compatible architectural format for the Subdivision, and shall have the rights, duties and responsibilities as delineated in the DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS of the COTTONWOOD MEADOWS SUBDIVISION, DOUGLAS COUNTY NEVADA. All future references to the COTTONWOOD MEADOWS SUBDIVISION HOMEOWNERS ASSOCIATION shall be "Association".

WHEREAS, the Declarants have developed their own individual lot's irrigation system and established a compatible architectural format for the Subdivision, and do have the right, duties and responsibility to manage the Association.

WHEREAS, the property developers filed the Association Corporation name with The Nevada Secretary of State. Thereafter the developers sold each lot, reserving the water right in favor of the Association Corporation. Presently the Association was "Permanently Revoked" as of August 1, 2011 by the Secretary of State. Refer to **Exhibit A.** 

WHEREAS, the Declarants acknowledge the Association is inactive and petition each other to dissolve the Association.

WHEREAS, NRS 533.087 (2017) "Adjudication of Vested Water Rights", requires a claimant of vested water rights to submit proof of claim before December 31, 2027. Failure to do so shall be deemed an "Abandonment" of the water right claim. The Declarants desire to comply with NRS 533.087 and HEREBY DISSOLVE the Association and EXERCISE management authority provided for in section 4.25 of the Declaration of Covenants, Conditions and Restrictions to re-convey the appurtenant water rights to each of the individual lots within the subdivision. Refer to Exhibit B.
