- The Decedent, MARILYN H. RODEFER, died on February 21, 2020, in Reno,
 Washoe County, Nevada.
- At the time of death, Decedent and her husband, ROBERT JACOB RODEFER,
 age 90, were registered at Brookdale of Reno for "respite care."
- 3. Since Decedent's time of death, Decedent's husband, ROBERT JACOB RODEFER, age 90, has remained at Brookdale Plumas.

On March 17, 2020, Nevada Governor Sisolak directed Nevadans to implement physical distancing measures to minimize opportunities for COVID-19 to spread from infected persons to non-infected persons. 
