GRANT, BARGAIN AND SALE DEED

THIS DEED is made this 21 day of APRIL, 2020, by and between WALTER R. HOWARD and DEBRA L. All replacements and additions shall also be covered by this Deed. All of the foregoing together with all personal property associated therewith is part of the Property described above.

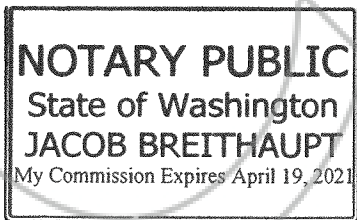
