**GRANT, BARGAIN AND SALE DEED**

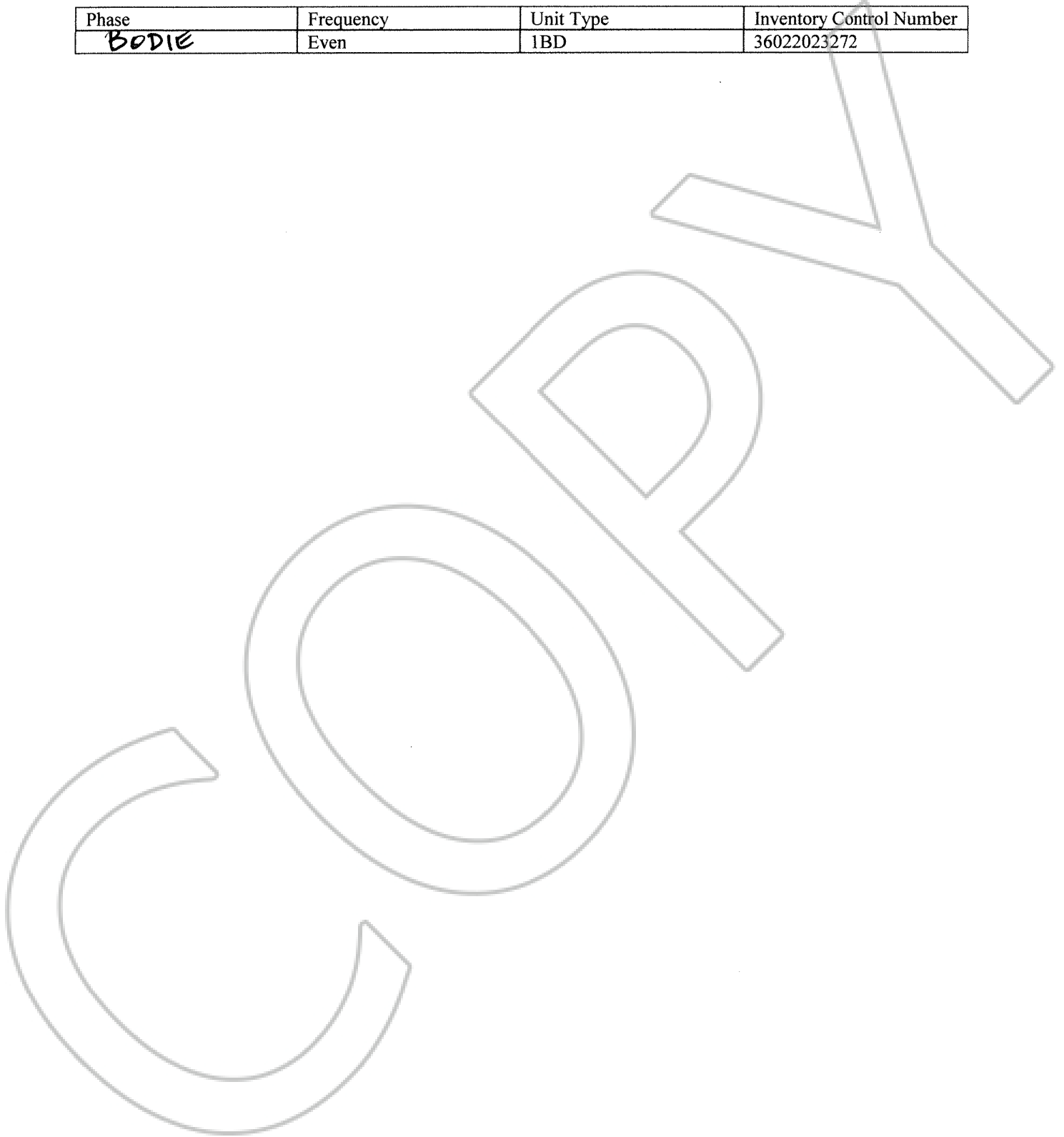

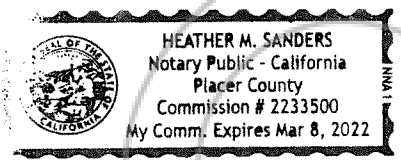
