LICENSE TO ENTER PROPERTY

This License to Enter Property ("License") is entered into by and between Douglas County, a political subdivision of the State of Nevada ("County"), and Elkhorn Landscape LLC, a Nevada limited liability company, and its Managing Member, Peter L. Yenkole, individually ("Licensee").

WHEREAS, County maintains and owns the public road known as Drayton Boulevard in Gardnerville, Nevada and has the sole jurisdiction and control of this public road ("Drayton Boulevard"); and

WHEREAS, Licensee desires to enter the unimproved section of Drayton Boulevard immediately adjacent to the property commonly known as 994 Springfield Drive, Gardnerville, Nevada (the "License Area") in order to perform landscaping services at 994 Springfield Drive, Gardnerville, Nevada.

NOW, THEREFORE, in consideration of the promises and covenants made herein, and other good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree as follows:

- County hereby grants a revocable license to Licensee and its employees and agents to
 enter the License Area to perform landscaping services to the residence located at 994
 Springfield Drive, Gardnerville, Nevada (the "Home").
- 2. The parties agree that any work performed by Licensee will be at Licensee's own expense and will not be for the benefit of the County.
- 3. During the term of this License, and for a period of one year after the License expires, Licensee promises and agrees to hold harmless County from any injury, insurance claim, or other claim arising directly or indirectly from the Licensee's activities on the Property.
- 4. Licensee agrees that it will not cause or allow hazardous materials to be brought to the License Area or upon any County road.
- 5. License promises and agrees to not conduct any activities that will destroy or otherwise disturb the License Area and will return the License Area to its original condition or better upon the expiration of this License.

6. The parties agree that County may revoke this License at any time by providing at

least 14 calendar days' advance written notice to Licensee. Unless otherwise

terminated earlier, this License will expire on September 23, 2020.

enforcing the License. In the event a dispute arises among the parties, the parties

promise and agree to first meet and confer to resolve any dispute. If such meeting

does not resolve the dispute, then any subsequent litigation may only proceed before a

department of the Ninth Judicial Court of the State of Nevada, in and for the County

of Douglas. The prevailing party shall be entitled to recover its reasonable attorney's

fees and costs incurred.

8. All notices, requests, demands and other communications allowed under this License

must be in writing and will be deemed delivered when sent via certified mail, return

receipt requested or by commercial courier, provided the courier's regular business is
