SUBORDINATION AGREEMENT

WITNESSETH:

CHANDLER, Trustee of the MICHAEL AND SHARRON CHANDLER REVOCABLE LIVING TRUST, DATED OCTOBER 26, 2009 (together, the "Owner") and encumbering that certain real property located at 1608 Jones St, Minden,, NV 89423- (address) which is legally described on Exhibit "A" attached hereto and uncorporated herein (the "Property"), which Security Document was recorded on 03/21/2014 in Official Records Book NA, Page NA, as Instrument No. 839795, of the Official Records of DOUGLAS County, NV, as the same may have been or is to be modified prior hereto or contemporaneously herewith.

WHEREAS, Bank of America, N.A.
