

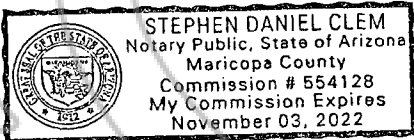

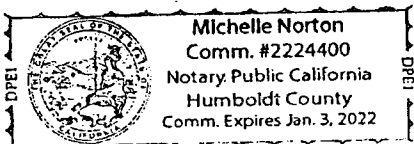

The State of Nevada has enacted a Homeowner's Bill of Rights ("SB 321") which establishes new requirements for judicial and non-judicial foreclosures of owner-occupied housing with loans that are secured by mortgages or deeds of trusts.

1.  **Exemption Does Not Apply.** We have confirmed that we are a financial institution, as defined in NRS 660.045 and have, during the immediately preceding annual reporting period, as established by our primary regulator, exceeded the 100 foreclosure (judicial and non-judicial) threshold. Therefore, the exemption does not apply to our organization.

2.  **Not a Financial Institution.** We are not a financial institution, as defined in the NRS 660.045, and therefore the exemption does not apply to our organization.
