QUIT-CLAIM DEED

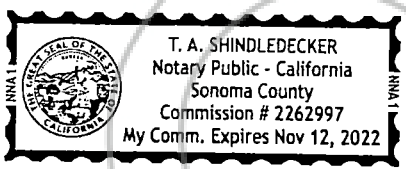

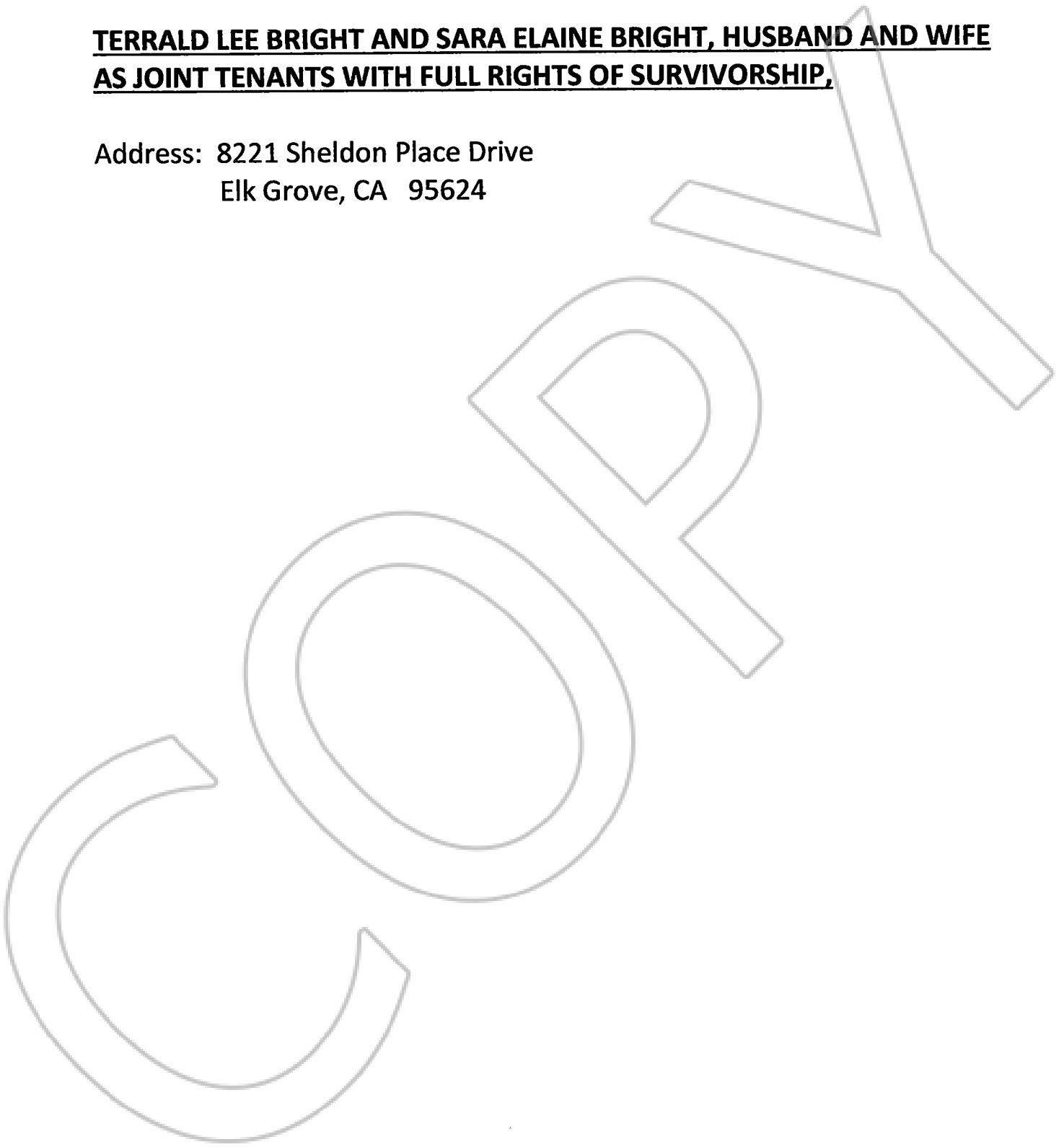
