



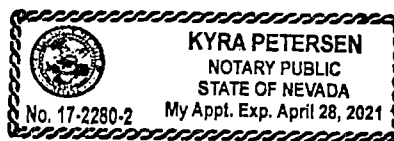

Recommendations:

The Obligor is the parent of the following child:

1 Using Obligor's testimony will be gainfully employed by Monday at Sierra Customs
2 Concrete, at hourly pay rate of \$18.00, working 40 hours per week. Obligor's gross
3 monthly earnings are \$3,120.00. Pursuant to the formula prescribed within NRS
4 125B.080 and NAC 425 et seq., 16% of those earnings, the state calculates an
5 obligation of \$499.00 per month.

6 The monthly child support obligation recommended in paragraph 1 below is adjusted
7 based on the following considerations contained in NAC 425.150:

8 Any special educational needs of the child:	_____	N/A;
9 The legal responsibility of the parties for the support of others:	_____	\$75.00;
10 The value of services contributed by either party:	_____	N/A;
11 Any public assistance paid to support the child:	_____	N/A;

14 Any other necessary expenses for the benefit of the child:	_____	N/A;
15 The Obligor's ability to pay:	_____	N/A;

17 The child support amount recommended by the Court Master (set out in paragraph 1
18 below) deviates from the statutory percentage under NAC 425 et seq., based on the
19 Obligor's cost of insurance for the child(ren) in the amount of N/A. NAC 425.135

20 The monthly child support amount recommended in paragraph 1 below deviates/is
21 adjusted from the statutory percentage under NRS 125B.080 and NAC 425 et seq.,
22 based on the reasonable cost of child care in amount of N/A and the Obligor will share
23 the equitable amount of N/A as part of the monthly child support obligation. NAC
24 425.130. Obligee testified there are no childcare cost at this time.

25 RECOMMENDED ORDER IS:

- 26 1. Ongoing support is ordered in the amount of \$424.00 per month beginning
27 August 1, 2020. The obligation for Child Support continues until the child turns 18
28 years of age, or until the child turns 19 years of age if the child is enrolled in High
School. NRS 425.300. However, this obligation to support a child is affected by a
child's ability to live on their own (NRS129.080 to 129.140 – legal emancipation) or

1 when applicable, continued financial support beyond the age of majority per NRS
2 125B.110.

3 2. The Obligor is responsible for **child support** arrears for the period of
4 April 1, 2020 through June 30, 2020.

5 A judgment is entered against the Obligor for **child support** arrears as follows:

6 Principal in the amount of \$3,391.30

7 Interest in the amount of \$225.62

8 Penalty in the amount of \$290.00

9 For a total judgment of \$3,906.92 to be repaid at \$40.00 per month beginning July 1, 2020.

10 All payments MUST be made in the form of a money order, cashier's check or business check
11 and payable to **STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU)** and sent
12 to:

16 The following information must be included with each payment:

17 A. Name (first, middle, last) of person responsible for paying child support.

18 B. Social Security Number of person responsible for paying child support.

19 C. Child support case number 207-48-4000A listed on each payment.

20 D. Name of custodian (first and last name of person receiving child support).

21 **PAYMENT OF SUPPORT IS TO BE AS PROVIDED HEREIN, AND THE GIVING OF**
22 **GIFTS, OF MAKING PURCHASES OF FOOD, CLOTHING AND THE LIKE WILL**
23 **NOT FULFILL THE OBLIGATION. NOTICE: NO CREDIT WILL BE GIVEN FOR**
24 **PAYMENTS PAID DIRECTLY TO THE OBLIGEE.**

25 3. All payments shall be made by immediate income withholding. If your full obligation
26 is not met by the amount withheld by your employer, you are responsible to pay the
27 difference between your court ordered obligation and the amount withheld by your
28 employer directly to the STATE COLLECTION AND DISBURSEMENT UNIT
(SCaDU). If you fail to do so you will be subject to the assessment of penalties and

1 interest. You may avoid these additional costs by making your current child support
2 payments each month.

3 4. The Obligee will cover the child's medical, vision, or dental health insurance needs
4 using either a private for fee insurance plan or public insurance plan. The accessible
5 and reasonable cost of medical support for the child is the amount of \$120.00 per
6 month. The Obligor will pay \$60.00 for the monthly medical cash support. NAC
7 425.135.

8 5. Pursuant NRS 425.382 et seq. and NAC 425 et seq., expenses for health care which
9 are not reimbursed through insurance, including expenses for medical, surgical, dental,
10 orthodontic and optical expenses, must be shared equally by both parents. If a parent
11 seeks reimbursement for a child's medical/dental expense not covered by insurance, that
12 parent must send proof of the expense to the other parent within 30 days of paying that
13 bill. The other parent then has 30 days to reimburse the paying parent 1/2 the cost of
14 that bill. The parents are required to comply with this provision for reimbursement
15 under this provision. The parents seeking enforcement of this provision must either go
16 to small claims court or district court to obtain a judgment against the other parent
17 before CSEP is required to collect on that judgment.

18 6. The Obligor shall keep the Division of Welfare and Supportive Services informed of
19 any change regarding current residential and/or mailing address, employment and of
20 access to health insurance coverage in WRITING (including health insurance policy
21 information) within 10 days of such change.

22 7. Obligor shall be responsible for ALL child support and judgment payments due.
23 Payment is to be made directly to the STATE COLLECTION AND
24 DISBURSEMENT UNIT (SCaDU). At any time withholding does not occur, Obligor
25 must make voluntary payments to the STATE COLLECTION AND DISBURSEMENT
26 UNIT (SCaDU).

27 8. Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances
28 (including payment in lieu of medical insurance) and spousal support balances, for

1 cases with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a
2 judgment of the court prior to July 1, 2004 will be enforced. Interest on the judgment
3 shall accrue at the rate established by NRS 125B.140(2)(c)(1).

4 9. A 10% penalty will be assessed on each unpaid installment, or portion thereof, of an
5 obligation to pay child support for a child, pursuant to NRS 125B.095 until January 31,
6 2020. All penalties accrued through that date will be enforced/collected until the
7 amount is paid in full.

8 10. The State of Nevada has continuing exclusive jurisdiction for enforcement and
9 modification purposes pursuant to the Full Faith and Credit for Child Support Orders
10 Act.

11 11. The Master finds that these Recommendations are in the best interest of the child.

12 It is further ordered that: Ongoing child support will remain at \$84.00 per month for the month
13 of July 2020. Ongoing child support will increase to \$424.00 per month effective August 2020.

14 Ongoing medical cash will remain at \$0.00 per month for the month of July 2020 and ongoing
15 medical cash will increase to \$60.00 per month effective August 2020.

If a motion to modify the order is not filed or a stipulation is not submitted, the child support obligation established in this order will continue until such time as all children who are the subject of this order reach 18 years of age or, if the youngest child who is subject to this order is still in high school when he or she reaches 18 years of age, when the child graduates from high school or reaches 19 years of age, whichever comes first. Unless the parties agree otherwise in a stipulation, any modification made pursuant to a motion to modify the order will be effective as of the date the motion was filed.

Unless a stay of this Order is obtained from District Court, all enforcement procedures including, but not limited to wage withholding, garnishment, liens and the attachment of federal income tax returns will be undertaken upon entry of this order.
