CERTIFICATE OF TRUST

The undersigned hereby certifies that on January 30, 1987 Earl A., Borowick and Jonnie C. Borowick created a revocable Living Trust. This Trust is known as the Borowick Trust dated January 30, 1987, for the benefit of the Borowick Family, and the undersigned Christopher Borowick became the Successor Trustee on October 6, 2020. Christopher Borowick, of 2351 Juniper Rd., Gardnerville, NV 89410, being first duly sworn, does hereby swear under penalty of perjury under the laws of the State of Nevada that the following statements are true:

- 1. By instrument dated January 30, 1987, Earl A. Borowick and Jonnie C. Borowick, as settlors and trustees, executed the Borowick Trust Agreement. On April 20, 2004, Earl A. Borowick and Jonnie C. Borowick, as settlors and trustees, executed a fully amended and restated Borowick Trust Agreement. On April 9, 2007, Earl A. Borowick and Jonnie C. Borowick, as settlors, and Earl A. Borowick, Jonnie C. Borowick, and Larry A. Borowick as trustees, executed a second fully restated and amended Borowick Trust, referred to herein after as the "Trust".
- 2. The Trust appointed Robert E. Borowick to serve as Successor Trustee upon the death or incapacity of Earl A. Borowick, Jonnie C. Borowick, and Larry A. Borowick. 
