## ORDER GRANTING STIPULATION APPROVING ORDER FOR RESIGNATION

AND REPLACEMENT OF TRUSTEE

UPON A READING of the parties' Stipulation Approving Order For Resignation And Replacement Of Trustee, IT IS HEREBY ORDERED as follows:

- 1. That the parties agree and it is therefore ordered that the parties grant each one to the other full and complete mutual releases as set forth in the "Mediation Settlement Agreement" (See, Stip. Exhibit 1).
- 2. That the parties agree and it is therefore ordered that the First Accounting through December 31, 2019 (See, Stip. Exhibit 2) and the Second Accounting through March 31, 2020 (See, Stip, Exhibit 3) are approved by all parties.
- 3. That the parties agree and it is therefore ordered that with respect to Jaquelyn E. Caldwell's duties as Trustee, all of the actions of Jaquelyn E. Caldwell, as Trustee of The Ruth

- 4. That the parties agree and it is therefore ordered that Jacquelyn E. Caldwell has resigned from the position as Trustee of The Ruth L. Carney Revocable Living Trust dated November 25,

2003, and this resignation is accepted by the beneficiaries, and that this resignation is effective upon the entry of the instant Court order, that the Court accepts this resignation, and appoints the replacement Trustee shown in the following paragraph.

- 5. That the parties agree and it is therefore ordered that the Dunham Trust Company, care of trust officer Alaina Sylvester, has been appointed by the Beneficiaries and shall be installed by the Court as the replacement Trustee of The Ruth L. Carney Revocable Living Trust dated November 25, 2003.
- 6. That the parties agree and it is therefore ordered that Jacquelyn E. Caldwell shall reasonably cooperate, at no expense to her, to transition documents and other things in her possession to Dunham Trust.
- 7.
