- 4.2 Therein, Petitioner STEVEN SMIT is the appointed and acting Personal Representative of Decedent GEORGE EDWARD CUMMINGS' Estate, having been appointed by Court Order entered or filed on June 29, 2020.
- 4.3 Letters Testamentary with Full Authority to Administer the Estate pursuant to the Independent Administration of Estates Act were issued in Petitioner STEVEN SMIT's name on July 1, 2020.
- 5. Petitioner STEVEN SMIT has, in his capacity as Personal Representative of Decedent GEORGE EDWARD CUMMINGS' Estate, discovered that title to Decedent GEORGE EDWARD CUMMINGS' personal residence in Douglas County, Nevada, is held in the name of GEORGE E. CUMMINGS, Trustee of the George E. Cummings Revocable Trust, dated November 18, 2000.

6.1 After conducting a diligent search for any trust documents in Decedent GEORGE EDWARD CUMMINGS' possession at the time of his death, or otherwise of record with any County or State agency at the time of Decedent GEORGE EDWARD CUMMINGS' death, Petitioner has been unable to locate any trust documents evidencing the past, present, or continuing existence of the *George E. Cummings Revocable Trust, dated November 18, 2000.* 

- 6.2 Petitioner STEVEN SMIT has not located, found, or discovered any asset or account in the name of the *George E. Cummings Revocable Trust, dated November 18, 2000,* since his appointment by the Court as the Personal Representative of the Estate of GEORGE EDWARD CUMMINGS.
- 6.3 Moreover, Decedent GEORGE EDWARD CUMMINGS' Last Will and Testament (hereinafter: "Last Will") dated November 2, 2018, which Last Will has been admitted to probate, does not contain a "pour-over" provision to the George E. Cummings Revocable Trust, dated November 18, 2000...
- 6.4 Lastly, the persons closest to Decedent GEORGE EDWARD CUMMINGS in the years prior to his death, named as Specific Distribution Devisees and as the Residual Distribution Devisee in Decedent's Last Will, have no knowledge of the existence (past or present) of the George E. Cummings Revocable Trust, dated November 18, 2000.

#### 7. Legal Authority

a) N.R.S. 143.060

NRS 143.060 authorizes a Personal Representative to maintain actions "...for the recovery of any property, real or personal, or for the possession thereof, or to quiet title thereto, or to determine any adverse claims thereon..." in cases in which the actions might have been brought/maintained by or against the decedents.

#### b) N.R.S. 153.031

NRS 153.031 authorizes a trustee or beneficiary of a trust to petition the court regarding any aspect of the affairs of the trust, including an action to terminate the trust. NRS 153.031(1)(n).

A petition under this section must state the grounds of the petition and the name and address of each interested person, and the relief sought by the petition. NRS 153.031(2).

#### IT IS THEREFORE REASONABLE TO CONCLUDE THAT:

8. Under these circumstances, if Decedent GEORGE EDWARD CUMMINGS did indeed, on November 18, 2000, create a legal and valid revocable living trust under Nevada law, known as the *George E. Cummings Revocable Trust dated November 18, 2000*, Decedent GEORGE E. CUMMINGS later terminated the trust instrument prior to his execution of his *Last Will* on November 2, 2018, or else Decedent's *Last Will* would have included a "pour-over" provision to the *George E. Cummings Revocable Trust, dated November 18, 2000*, and, at the time of Decedent's death, other assets comprising Decedent's Estate would have been found to be titled in the name of the *George E. Cummings Revocable Trust, dated November 18, 2000*. As it stands, the only asset that is (or remains) titled in the name of the *George E. Cummings Revocable Trust, dated November 18, 2000*.

### **ACCORDINGLY**, the Court find and orders as follows:

- A. That interested parties have received sufficient notice under NRS 153.031 and 155.010;
- B. That the George E. Cummings Revocable Trust, dated November 18, 2000, is terminated pursuant to NRS 153.031(1)(n);
- C. That the Trust asset(s)/real property at issue be transferred, conveyed, distributed, delivered, and confirmed to Petitioner STEVEN SMIT, the Personal Representative of Decedent's Estate. The Trust asset(s)/real property at issue is known and located at 237
