

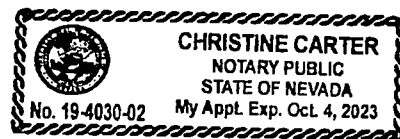

15 *The undersigned does hereby affirm this document does not contain the social security number of any*

17 This matter was heard on February 12, 2021 for the Notice and Finding of Financial
18 Responsibility. The Court Master with the following were present:

19 Obligee: Present, via telephone

20 Obligor: Not Present

21 Presented by: Alyssa Matovina Division of Welfare and Support Services
22 Child Support Enforcement

23 After considering all the evidence, the Master hereby makes the following Findings and
24 Recommendations:

25 The Obligor was properly served on December 8, 2020, with a Notice and Finding of
26 Financial and Responsibility.

27 Obligor is the parent of Daniel Joseph Coker, born March 25, 2018.

1 Obligor was properly served and noticed of today's hearing at his last known address
2 and failed to appear.

3 Using actual earnings, Obligor's gross monthly earnings are \$4,474.00. Pursuant to the
4 formula prescribed within NRS 125B.080 and NAC 425 et seq., 16% of those earnings,
5 the state calculates an obligation of \$716.00 per month.

6 The monthly child support obligation recommended in paragraph 1 below is considered
7 based on the following provisions contained in NAC 425.150:

17 The child support amount recommended by the Court Master (set out in paragraph 1
18 below) deviates from the statutory percentage under NAC 425 et seq., based on the
19 Obligor's cost of insurance for the child in the amount of N/A. NAC 425.135

20 The monthly child support amount recommended in paragraph 1 below deviates/is
21 adjusted from the statutory percentage under NRS 125B.080 and NAC 425 et seq.,
22 based on the reasonable cost of childcare in amount of N/A and the Obligor will share
23 the equitable amount of N/A as part of the monthly child support obligation. NAC
24 425.130. Oblige testified that she does not have any childcare costs at this time.

25 THE RECOMMENDED ORDER:

- 26 1. The Obligor shall pay \$716.00 per month in ongoing support beginning
27 March 1, 2021. The obligation for Child Support continues until the child turns 18
28 years of age, or until the child turns 19 years of age if the child is enrolled in High
School. However, this obligation to support a child is affected by a child's ability to
live on their own (NRS129.080 to 129.140 – legal emancipation) or when applicable,
continued financial support beyond the age of majority per NRS 125B.110.

1 2. An arrears Judgment is entered in the amount of **\$3,580.00** for October 1, 2020
2 through February 28, 2021.

3 To be paid by payments of **\$50.00** per month beginning March 1, 2021.

4 All payments MUST be made in the form of a money order, cashier's check or business check
5 and payable to **STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU)** and sent
6 to:

10 The following information must be included with each payment:

11 A. Name (first, middle, last) of person responsible for paying child support.

12 B. Social Security Number of person responsible for paying child support.

13 C. Child support case number 787-77-6200B listed on each payment.

14 D. Name of custodian (first and last name of person receiving child support).

15 **PAYMENT OF SUPPORT IS TO BE AS PROVIDED HEREIN, AND THE GIVING OF**
16 **GIFTS, OF MAKING PURCHASES OF FOOD, CLOTHING AND THE LIKE WILL**
17 **NOT FULFILL THE OBLIGATION. NOTICE: NO CREDIT WILL BE GIVEN FOR**
18 **PAYMENTS PAID DIRECTLY TO THE OBLIGEE.**

19 3. All payments shall be made by immediate income withholding. If your full obligation
20 is not met by the amount withheld by your employer, you are responsible to pay the
21 difference between your court ordered obligation and the amount withheld by your
22 employer directly to the STATE COLLECTION AND DISBURSEMENT UNIT
23 (SCaDU). If you fail to do so you will be subject to the assessment of penalties and
24 interest. You may avoid these additional costs by making your current child support
25 payments each month.

26 4. The Obligee will cover the child's medical, vision, or dental health insurance needs
27 using either a private for fee insurance plan or public insurance plan. The accessible
28 and reasonable cost of medical support for the child is the amount of **\$0.00** per month.

The Obligor will pay **\$0.00** for the monthly medical cash support. NAC 425.135.

- 1 5. Pursuant to NRS 425.3824(1)(d) and NAC 425 et seq., expenses for health care
2 which are not reimbursed through insurance, including expenses for medical, surgical,
3 dental, orthodontic and optical expenses, must be shared equally by both parents. If a
4 parent seeks reimbursement for a child's medical/dental expense not covered by
5 insurance, that parent must send proof of the expense to the other parent within 30 days
6 of paying that bill. The other parent then has 30 days to reimburse the paying parent
7 1/2 the cost of that bill. The parents are required to comply with this provision for
8 reimbursement under this provision. The parents seeking enforcement of this provision
9 must either go to small claims court or district court to obtain a judgment against the
10 other parent before CSEP is required to collect on that judgment.
- 11 6. The Obligor shall keep the Division of Welfare and Supportive Services informed of
12 any change regarding current residential and/or mailing address, employment and of
13 access to health insurance coverage in **WRITING** (including health insurance policy
14 information) within 10 days of such change.
- 15 7. Obligor shall be responsible for ALL child support and judgment payments due.
16 Payment is to be made directly to the STATE COLLECTION AND
17 DISBURSEMENT UNIT (SCaDU). At any time withholding does not occur, Obligor
18 must make voluntary payments to the STATE COLLECTION AND DISBURSEMENT
19 UNIT (SCaDU).
- 20 8. Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances
21 (including payment in lieu of medical insurance) and spousal support balances, for
22 cases with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a
23 judgment of the court prior to July 1, 2004 will be enforced. Interest on the judgment
24 shall accrue at the rate established by NRS 125B.140(2)(c)(1).
- 25 9. The State of Nevada has continuing exclusive jurisdiction for enforcement and
26 modification purposes pursuant to the Full Faith and Credit for Child Support Orders
27 Act.
- 28 10. The Master finds that these Recommendations are in the best interest of the child.

Pursuant to NRS 125B.145 this Order may be reviewed every three (3) years and is subject to future modifications.

NOTICE: Pursuant to NAC 425.165, if you want to adjust the amount of child support established in this order, you **MUST** file a motion to modify the order with or submit a stipulation to the court. If a motion to modify the order is not filed or a stipulation is not submitted, the child support obligation established in this order will continue until such time as all children who are the subject of this order reach 18 years of age or, if the youngest child who is subject to this order is still in high school when he or she reaches 18 years of age, when the child graduates from high school or reaches 19 years of age, whichever comes first. Unless the parties agree otherwise in a stipulation, any modification made pursuant to a motion to modify the order will be effective as of the date the motion was filed.

Unless a stay of this Order is obtained from District Court, all enforcement procedures including, but not limited to wage withholding, garnishment, liens and the attachment of federal income tax returns will be undertaken upon entry of this order.
