<u>AFFIDAVIT OF CHANGE OF TRUSTEES</u> (Water Rights)

The undersigned hereby affirms that this document submitted for recording DOES contain the personal information of any person or persons per N.R.S. 440.380

After being duly sworn, SARA H. GROENENDYKE, also known as SARA GROENENDYKE, Trustee of the GROENENDYKE FAMILY TRUST, dated March 2, 1978, as amended, confirms and certifies the following to be true:

- 1. The name of the Trust to which this affidavit applies is the GROENENDYKE FAMILY TRUST, dated March 2, 1978, as amended (the "Trust").
- 2. The Trust was created on March 2, 1978 by EDWARD H. GROENENDYKE, III and SARA H. GROENENDYKE, as Grantors.
- 3. The original Trustees of the Trust are EDWARD H. GROENENDYKE, III and SARA H. GROENENDYKE.

- 4. EDWARD H. GROENENDYKE, III died on September 7, 2020. A copy of EDWARD H. GROENENDYKE, III's death certificate is attached hereto as **Exhibit** "A".
- 5. EDWARD H. GROENENDYKE, III and SARA GROENENDYKE, Trustees of the GROENENDYKE FAMILY TRUST of March 2, 1978, as amended, and Restated on February 14, 1989, acquired any and all water rights title, applications and privileges, whether surface or subsurface, certified or permitted, primary or supplemental, historic or incidental to the property and was named as the Grantees in that certain Quitclaim Deed (Water Rights) recorded on March 20, 2000, as Document No. 0488220 in the Official Records of the Douglas County Recorder, Nevada, covering the water rights described on Exhibit "B", attached hereto and made a part hereof situate in the County of Douglas, State of Nevada.
- 6. The current acting Successor Trustee is SARA H. GROENENDYKE who is appointed pursuant to Section 9.5 A. of Article IX of the Trust, which provides, in pertinent part, as follows:
 - "Section 9.5 Successor Trustee.
 - A. Except for the trust established in Section 4.5, if EDWARD H. GROENENDYKE, III is unable, unwilling or ceases to serve as Trustee, then SARA H. GROENENDYKE shall serve as sole Trustee.

Should SARA H. GROENENDYKE predecease EDWARD H. GROENENDYKE, III or is unable, unwilling or cease to serve as Trustee, then EDWARD H. GROENENDYKE, III, ELIZA OCEANUS GROENENDYKE GILSDORF and GWEN WARBURTON shall serve as successor co-Trustees of the Trust. If either ELIZA OCEANUS GROENENDYKE GILSDORF or GWEN WARBURTON is unable, unwilling or cease to serve as trustee, the remaining named individual and EDWARD H. GROENENDYKE, III shall serve as Co-Trustees. If EDWARD H. GROENENDYKE, III, and either ELIZA OCEANUS GROENENDYKE GILSDORF or GWEN M. WARBURTON, is unable, unwilling or ceases to serve as a Co-Trustee, then the remaining named individual (ELIZA OCEANUS GROENENDYKE GILSDORF or GWEN M. WARBURTON, as the case may be) shall serve as sole Trustee.

However, the remaining individual trustee shall promptly designate in writing a successor Co-trustee to serve for either EDWARD H. GROENENDYKE, III or the then serving trustee.

Any successor or substitute Trustee needed for this trust shall be chosen, in order of priority, from the following:

- 1. One designated, in writing, by concurrence of the Trustees then serving;
- 2. One designated, in writing, by one of the Trustees when serving alone;
- 3. One designated, in writing, by a majority of the adult beneficiaries currently eligible to receive income or principal distributions;
- 4. In the absence of such designation, then by appointment of the Second Judicial District Court, in and for the County of Washoe, State of Nevada."
- 5. Upon the recording of this Affidavit, title to the property may be held in any of the following ways:
 - (i) "SARA H. GROENENDYKE, Trustee of the GROENENDYKE FAMILY TRUST, dated March 2, 1978, as amended"; or,
 - (ii) "SARA H. GROENENDYKE, Trustee of the GROENENDYKE FAMILY TRUST, dated March 2, 1978"; or,
 - (iii) "SARA H. GROENENDYKE, Trustee of the GROENENDYKE FAMILY TRUST; or,
 - (iv) Such other name as the Trustee designates and certifies.


