PUBLIC UTILITY EASEMENT

THIS GRANT OF EASEMENT AND AGREEMENT, made and entered into this day of _______, 2021, by and between TAHOE RH 195, LLC, Party of the First Part, hereinafter referred to as "Grantor"; and the ROUND HILL GENERAL IMPROVEMENT DISTRICT, a general improvement district organized pursuant to Nevada Revised Statutes Chapter 318, Party of the Second Part, hereinafter referred to as "Grantee".

WITNESSETH:

For and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, receipt of which is hereby acknowledged, Grantor hereby grants to Grantee a permanent easement and right of way for Round Hill General Improvement District facilities upon, over, across and through the land herein described, together with perpetual right to construct, reconstruct, maintain and repair said facilities, namely the installation, construction, and maintenance of an in-ground sewage flow monitoring device.

The easement and right of way hereby granted is situated in the County of Douglas, State of Nevada, more particularly described in Exhibit "A" and as depicted on Exhibit "B" attached hereto and by this reference made a part hereof.

TO HAVE AND TO HOLD, said easement and right of way, unto the Grantee and unto its successors and assigns forever.

Permission is hereby granted to the Round Hill General Improvement District, its authorized agents and/or its contractors to enter in and upon said easement described in Exhibit "A" and depicted on Exhibit "B" and made a part hereof, for the purpose of constructing,

reconstructing, maintaining, or servicing the facilities on the Grantor's property and to accomplish all necessary incidents thereto in case the grantor does not maintain the property in a manner that allows for the safe, efficient, and normal operation of the sewage flow monitoring device.

This is a non-exclusive easement and to the extent that other uses do not interfere with the use of said easement by Grantee as permitted hereunder, Grantor, its successors and assigns, shall be permitted to use the same for any purpose they may desire.

The covenants and agreements herein contained shall inure to the benefit of and shall be binding upon the executors, administrators, heirs, successors and assigns of the parties and shall be, and are, covenants running with the land binding upon said property of Grantor and for the benefit of Grantee as described in Exhibit "A" and as depicted on Exhibit "B".

EXHIBIT "A" LEGAL DESCRIPTION FOR PUBLIC UTILITY EASEMENT

All that certain real property lying within a portion of the Southeast One-Quarter (SE 1/4) of Section Fifteen (15), Township Thirteen (13) North, Range Eighteen (18) East, in the County of Douglas, State of Nevada, further described as being Adjusted Parcel 05-290-10 per Record of Survey To Support A Boundary Line Adjustment for "Round Hill Square, Ilc", per Document 577574, recorded on May 21, 2003, filed in the Official Records of said county and being further described as follows:

COMMENCING at an angle point on the southeasterly boundary of said adjusted parcel, marked by a 5/8" rebar & cap — PLS 11172;

THENCE North 16°28'10" West, 18.05 feet to the northwesterly boundary of an existing 20' wide water and sanitary sewer easement per Document 50671, recorded on December 21, 1970, filed in official records of said county, also being the POINT OF BEGINNING;

THENCE continuing on the northwesterly boundary of said existing easement, South 42°14'04" West, 11.12 feet;

THENCE on the southwesterly boundary of said existing easement, North 44°28'45" West, 13.43 feet, from which the southwesterly corner of said adjusted parcel, marked by a 5/8" rebar and cap – PLS 11172, bears, North 46°13'01" West, 108.47 feet;

THENCE departing said existing easement, South 85°24'52" East, 16.94 feet to the POINT OF BEGINNING

Containing 75 square feet of land, more or less;

Note: The extents of said easement are to be lengthened and shortened to the northwesterly and southwesterly boundary of said existing water and sanitary sewer easement.
