- 1. <u>Trustor</u> shall properly care for and keep such property in good condition and repair, not to remove or demolish any building thereon, to complete in good and workmanlike manner any building that may be constructed thereon, and to pay when due all claims for labor performed and material furnished therefore, to comply with all laws, ordinances, and regulations requiring any alterations or improvements to be made thereon, not to commit or permit any waste thereof, not to commit, suffer, or permit any act to be done in or upon such property in violation of law, to cultivate, irrigate, fertilize, fumigate, prune and/or do any other act or acts, all in a timely and proper manner, which, from the character at use of such property, may be reasonably necessary, the specific enumerations herein not excluding the general.
  - 2. <u>Trustor</u> agrees to pay and discharge all costs, fees, and expenses of these Trusts, including cost of evidence of title and Trustee's fees in connection with sale, whether completed or not. Such amounts shall become due upon delivery to Trustee of Declaration of Default for Sale, as hereinafter provided.

- 5. Any award of damages in connection with any condemnation for public use of or irjury to any property or any part thereof is hereby assigned and shall be paid to Beneficiary, who may apply or release such moneys received by it in the same manner and with the same effect as herein provided for disposition of proceeds of insurance.
- 6. Trustee shall be under no obligation to notify any party hereto of any pending sale hereunder or of action or proceeding of any kind with which Trustor, Beneficiary, and/or Trustee shall be mamed as defendant unless brought by Trustee.
- 7. Acceptance by Beneficiary of any sum in payment of any amounts secured hereby, after the date when the same is due, shall not constitute a waiver of the right either to require prompt payment when due, of all other sums so secured or to declare default as herein provided for failure to pay.
- 8. Trustee may, at any time, or from time to time, without liability therefor and without notice, upon written request of Beneficiary and presentation of this Deed of Trust, consent in writing of making of any map or plot thereof, join in granting any endorsement thereon; or join in any extension agreement or subordination agreement connected herewith.

- 9. Upon receipt of written request from Beneficiary requiring that all sums secured hereby have been sold and upon surrender of this Deed and upon payment of fees the Trustee shall recovery without warranty the property then held hereunder. The records in such reconveyance shall be conclusive proof of the truth thereof. Trustor in such reconveyance may be described in general terms as the person or persons legally entitled thereto. Should default be made by Trustor in payment of any amounts secured hereby and/or and in performance of any agreement herein, then Beneficiary may declare all amounts secured hereby immediately due by delivery to Trustee of a written declaration of default and demand for sale, and of written notice of default and election to cause such property to be sold (which Trustee shall cause to be filed for record) and shall surrender to Trustee this Deed and all documents evidencing any expenditure secured hereby.
- 10.
