8. The exact amount due on the Judgment as of May 4, 2021, is \$17,308.60.



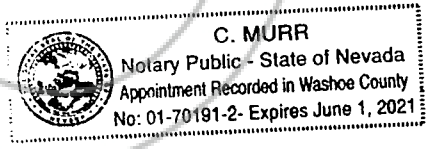
