It is hereby ordered as follows:

- 1. The decedent's Last Will and Testament, dated January 24th, 2007; her codicil dated June 10, 2014; and her codicil dated May 2, 2018, are all hereby ordered admitted to probate.
- 2. Decedent's purported codicil dated September 3, 2015, is not recognized as an effective testamentary instrument.
- 3. Decedent nominated Deanna Kennedy and Mary Mercurio to act as co-personal representatives of the decedent's estate. Both have expressed their desire and willingness to so act and both are qualified.
