SUBORDINATION AGREEMENT

WHEREAS, Owner has executed, or is about to execute, a deed of trust and note in the sum of 800,000.00 dated July 2, 2021 in favor of Simon Properties, LLC, hereinafter referred to as "Lender," payable with interest and upon the terms and conditions described therein, which deed of trust is to be recorded concurrently herewith; and
