QUIT-CLAIM DEED

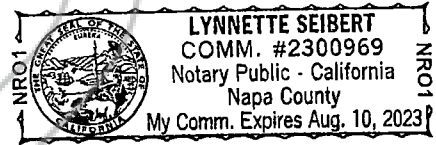
