GRANT, BARGAIN AND SALE DEED

THIS DEED is made this 3 day of March, 2021, by and between **Anne M. 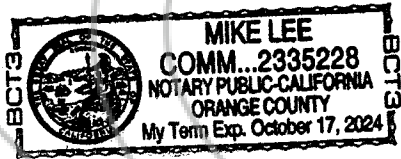
