**GRANT, BARGAIN AND SALE DEED**

**THIS DEED** is made this 15 day of Feb, 2021, by and between **David P. Schmitter and Marlys E. 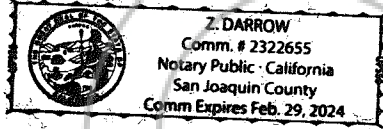
