GRANT, BARGAIN AND SALE DEED

THIS DEED is made this 12 day of Feb, 2021, by and between **Raymond L. Nichols, Jr. and Holly H. 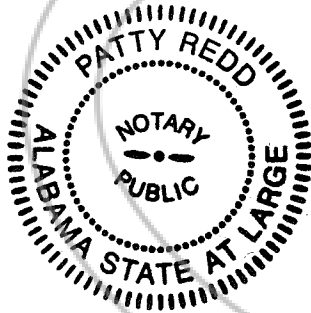
