A Timeshare Estate comprised of:

Parcel One:

A Sierra Share consisting of an undivided 1/51st interest in and to that certain condominium estate described as follows:

- (A) Condominium Unit No. A1 as shown on the Condominium Plan filed December 27, 1983, in Book 1283 of Maps, at Page 3079, Map No. 93408 in the Office of the County Recorder of Douglas County, State of Nevada.
- (B) An undivided 1/51st interest in and to Lot 4 of Tahoe Sierra Resort as per Map recorded December 27, 1983 as Document No. 93408, at Book 1283, Page 3079, records of Douglas County, Nevada.
