GRANT, BARGAIN AND SALE DEED

amended from time to time; and (iii) Real Estate Taxes that are currently not due and payable but are a lien against the Property.

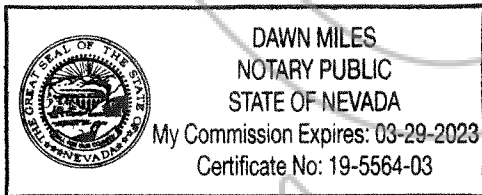
