**GRANT, BARGAIN AND SALE DEED**

**THIS DEED** is made this 6 day of Feb, 2021, by and between **JOHN V MARTIN and SHIRLENE L. 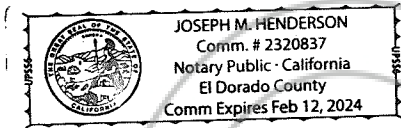
