The court also requested a 22 copy of a deed be filed into the court record demonstrating decedent's ownership interest in 23 the parcel of real property at issue within the petition. 24 On June 1, 2021, Angela Sue Colgan caused to be filed an authenticated copy of a 25 Grant, Bargain and Sale Deed representing the decedent's sole and separate property interest in the parcel of real property at issue and a notarized Waiver of Rights of Inheritance

executed by the decedent's daughter, Brooke Colgan.

Proof of service regarding adequate notice of the proceedings to both the Medicaid

Estate Recovery office of the State of Nevada and the decedent's daughter, Brooke Colgan,
was present within the record. No objection has been received from any interested person
during the year these summary proceedings have been open and pending before the court.

Having examined all relevant pleadings and papers on file herein, and hearing no objection, the court approved the administrator's petition on June 8, 2021, and now finds as follows:

- 1. Notice of the hearing of the petition has been regularly given as prescribed by law.

- 5. The decedent died leaving an estate in the State of Nevada having a value less than \$300,000.00, which is subject to the jurisdiction of the court.
- 6. On June 23, 2020, Angela Sue Colgan was appointed as administrator of David Richard Colgan's estate and authorized to summarily administer decedent's estate. Angela Sue Colgan has been the administrator of decedent's estate continuously since that date.
- 7. Notice to creditors was published locally in The Record-Courier newspaper on August 1, 8, and 15, 2020.
 - 8. No claims against the estate have been filed into the court record or brought to the

attention of the court.

- 9. Brooke Colgan has waived any interest she may have as an heir to her father's estate.
- 10. No objection has been received from any interested person during the year these proceedings have been open before the court.
 - 11. No statutory fee for the administrator's services has been requested.
 - 12. The estate is now in a condition to be closed and distributed.

THEREFORE, based upon the foregoing, the administrator of decedent's estate is hereby authorized to distribute all of the assets of the estate specifically as follows:

To Angela Sue Colgan as her sole and separate property, including the real property located at 1000 Arrowhead Drive, Gardnerville, Nevada 89410, APN 1220-16-510-013, and more particularly described as follows:

Upon filing a petition for discharge demonstrating that the distribution set forth herein has been received by the identified heir in the manner affirmed by the court, the administrator will be discharged from her duties without further hearing.
