A portion of PERMIT NO. 53363, being 6.0 acre-feet of water annually together with pro rata rates of diversion.





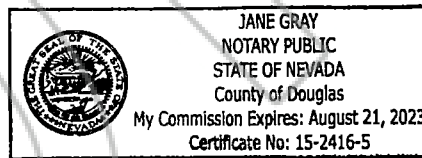
