Description of Trust

The undersigned hereto desires to confirm the establishment of a revocable and amendable Living Trust on June 9, 2013, and amendments thereto, for the benefit of the Trustor and containing inter alia the following provisions:

- Alice Meyer is designated as the Trustee to serve until her death, resignation or incompetence.


