THIS COURT FINDS that ERICH GREIMEISTER (hereinafter "Decedent") died on November 16, 2018, in Austria.

THIS COURT FURTHER FINDS that the Decedent was, at the date of his death, a citizen of Austria and a lawful permanent resident of the United States of America, residing at 226 Pepi Drive Gardnerville, NV 89410. Thus, a resident of Douglas County, state of Nevada.

THIS COURT FURTHER FINDS that the Decedent left an estate in Nevada, county of Douglas, consisting of real property.

THIS COURT FURTHER FINDS that the Decedent died intestate.

THIS COURT FURTHER FINDS that the Decedent died leaving a surviving spouse, but without leaving an issue, parent, brother or sister, or children of any issue surviving spouse.
