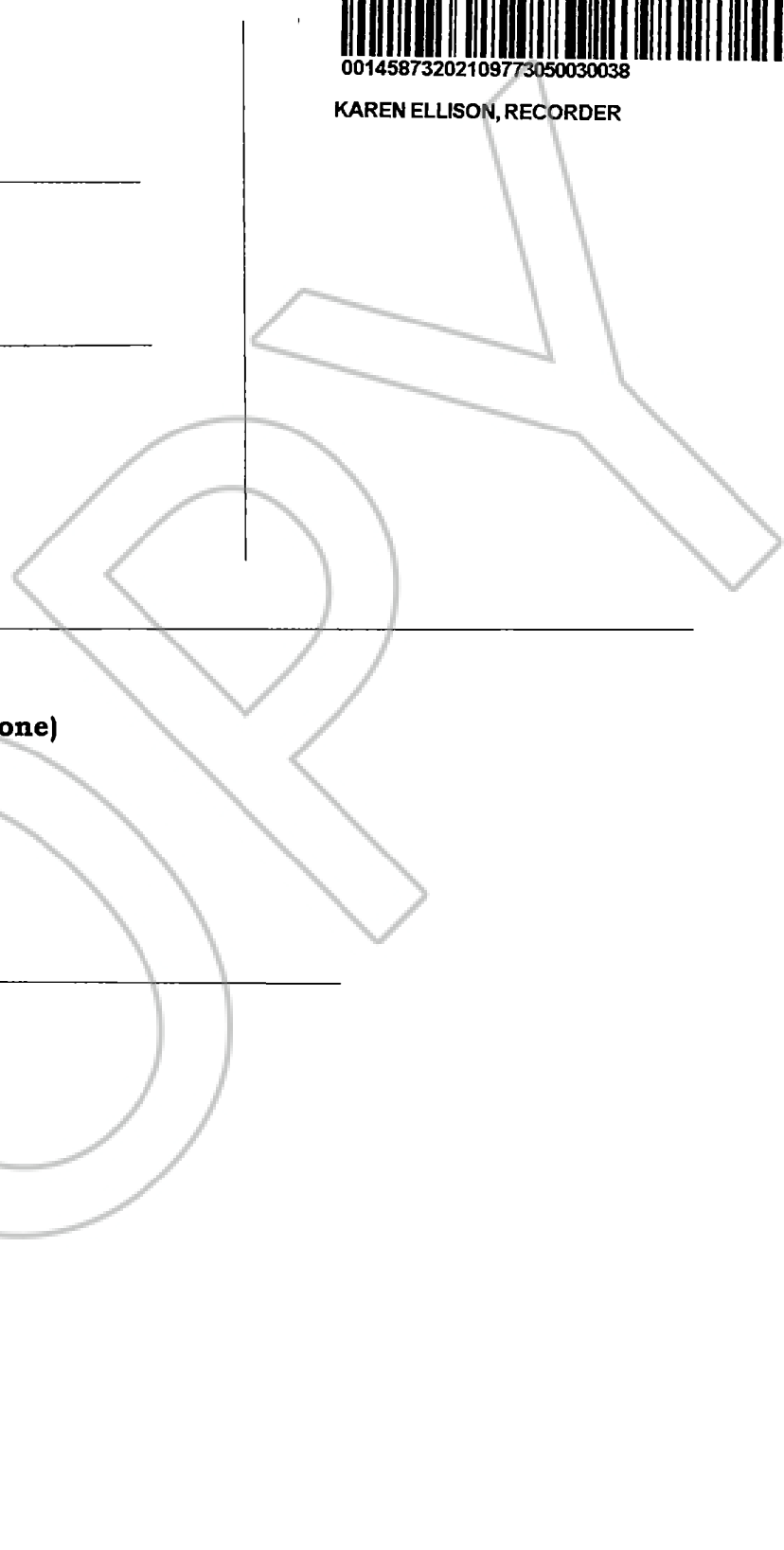

WHEREAS, Douglas County, (hereafter County) a political subdivision of Douglas County and the State of Nevada, from time to time requires the services of Independent Professional Services (hereafter Agreement"); and

WHEREAS, on July 16, 2021, the County entered into an agreement with Charlotte Altamirano (hereafter "Contractor"). The County and Contractor are at times collectively referred to hereinafter as the "Parties or individually as the "Party"; and

WHEREAS, both Parties agree to amend the Agreement, as allowed, to extend the term of the Agreement and to expand the total not to exceed cost of all services.

NOW, THEREFORE, in consideration of the agreements herein made, the parties mutually agree all provisions of the original Agreement remain in full force and effect with the exception of the following amendments which show deleted language with a ~~strikethrough~~ and new/amended language in *italics*:

- A. Page 1, Paragraph 1, EFFECTIVE DATE OF AGREEMENT. This Agreement shall be effective as of ~~the date of execution December 11, 2021~~, and will terminate on ~~December 10, 2021~~ *March 11, 2022...*
- B. Page 2, Paragraph 5, INDUSTRIAL INSURANCE: "...Charlotte Altamirano, has entered into an agreement with Douglas County to perform onboarding and other personnel related services August 1, 2021 to ~~December 10, 2021~~ *March 11, 2022*. and is in compliance with the provisions of NRS Chapters 616A to 616D, inclusive."

This First Amendment and the Agreement entered into on the latter of the signature dates below together, constitute the entire Agreement between the Parties and may only be modified by a written amendment signed by the Parties.

IN WITNESS WHEREOF, the parties hereto have caused this First Amendment for professional services between Charlotte Altamirano, and Douglas County to be signed and intend to be legally bound thereby.

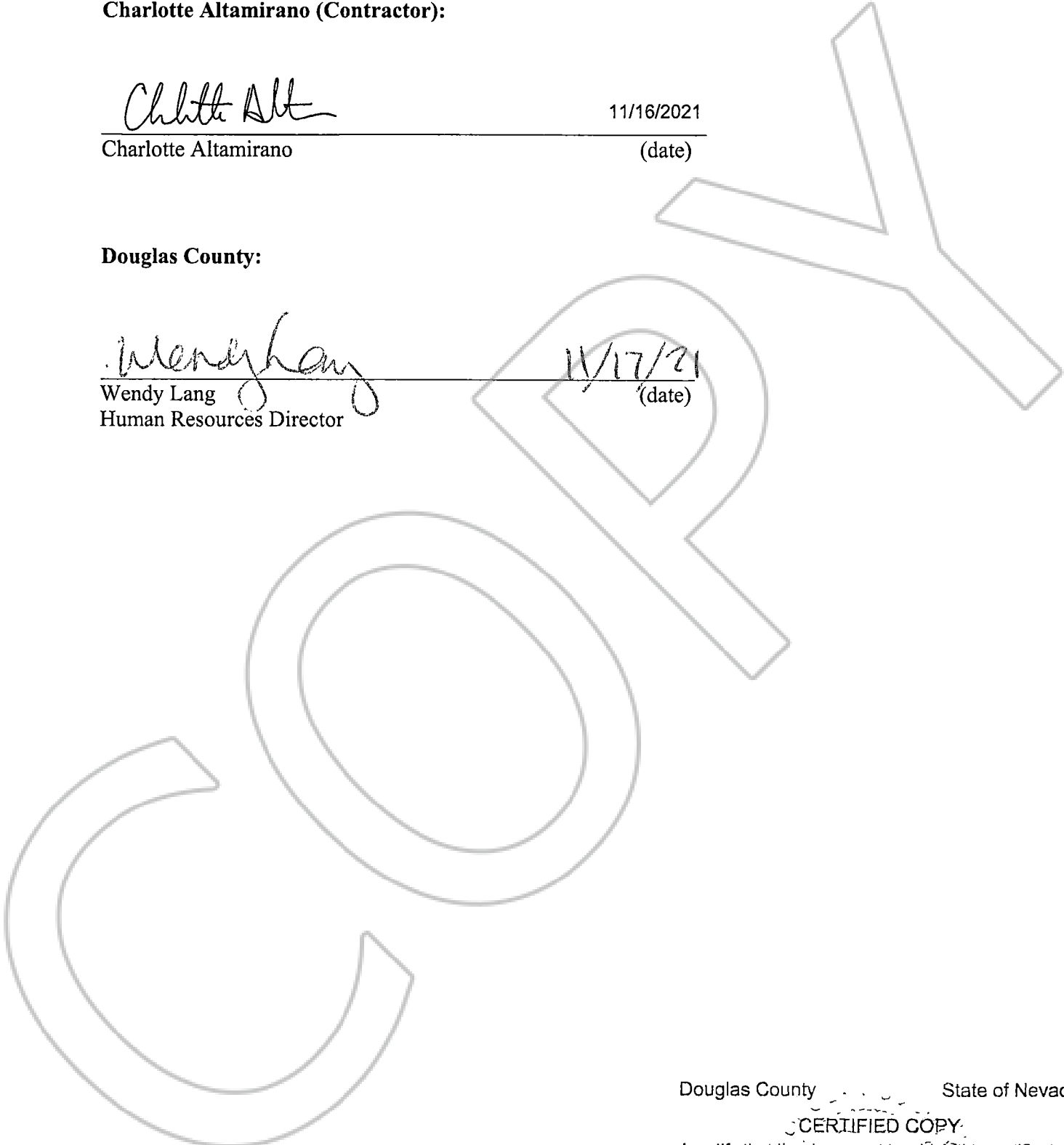
