WHEREAS, Douglas County, (hereafter County) a political subdivision of Douglas County and the State of Nevada, from time to time requires the services of Independent Professional Services (hereafter Agreement"); and

- B. Page 2, Paragraph 5, INDUSTRIAL INSURANCE: "... Charlotte Altamirano, has entered into an agreement with Douglas County to perform onboarding and other personnel related services August 1, 2021 to December 10, 2021 March 11, 2022. and is in compliance with the provisions of NRS Chapters 616A to 616D, inclusive."

This First Amendment and the Agreement entered into on the latter of the signature dates below together, constitute the entire Agreement between the Parties and may only be modified by a written amendment signed by the Parties.
