## NOTICE CONFIRMING APPOINTMENT OF SUCCESSOR TRUSTEE

WHEREAS, GARY B. CASTEEL and CLAUDIA A. CASTEEL, JR. or LORI SMALL-BROOKE to act as successor co-trustee, then the other of them shall serve alone as successor trustee of this trust and of each separate trust created by this instrument.
