for valuable consideration, the receipt of which is hereby acknowledged, does hereby Grant, Bargain, Sell and Convey to


TAHOE SUMMIT VILLAGE TIME SHARE ASSOCIATION, a Nevada non-profit corporation



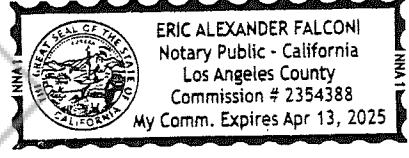
