ORDER ON PETITION FOR ASSUMPTION OF JURISDICTION AND CONFIRMATION OF APPOINTMENT OF SUCCESSOR TRUSTEE; PETITION FOR ORDER TRANSFERRING PROPERTY INTO TRUST

Upon submission of a verified Petition for Assumption of Jurisdiction and Confirmation of Appointment of Successor Trustee; Petition for Order Transferring Property Into Trust [NRS 163.002 and NRS 164.015] by Laurence Hill, as Successor Trustee of the HILL FAMILY TRUST dated February 22, 1997 ("Trust"), representing as follows:

- RICHARD L. HILL ("Richard") and LAVERNE ELIZABETH ("Laverne") 1. husband and wife, as Trustors, and the original Trustees, created a written Hill Family Trust Agreement (the "Trust Agreement") on February 22, 1997.
- LaVerne died April 23, 1998, she was survived by Richard. 2.

3. Richard signed a First Amendment to the Trust Agreement dated May 4, 2011 and another purported First Amendment to the Trust Agreement dated December 22, 2011. Upon the death of LaVerne, the trust became irrevocable. Therefore, all of the beneficiaries had to consent to the amendment, which they did with respect to the amendment signed May 4, 2011. In the May 4, 2011 amendment, Richard included his new wife, Leila Anne Hill, as the first successor trustee and beneficiary with Laurence L. Hill as the second successor trustee. Richard's four children were listed as alternate beneficiaries. The same is true as to the December 22, 2011 amendment as far as the successor trustees. However, in the second document, Richard also removed his son, Robert L. Hill, as a beneficiary due to his death. Richard removed his sister, Rosemary Breech, as a beneficiary in both amendments as well as she was deceased and had received her payment prior to her death.

- 4. On January 25, 2020, Richard passed away leaving his then wife, Leila Anne Hill, as the Successor Trustee. Pursuant to the Amendments to the Trust Agreement, Leila Hill received the benefit of the Trust assets after the death of Richard.
- 5. Leila Anne Hill is now deceased, having died on August 17, 2021. She is survived by two sons, Richard Scott Lenton and John Wade Lenton, who received notice of this hearing. With the death of Leila Anne Hill, Laurence R. Hill is the successor trustee pursuant to the First Amendment.
- 6. The First Amendment provides that the following are the beneficiaries after Leila Anne Hill, who takes per capita:

1/3 to Laurence R. Hill

1/3 to Deborah M. Zamor; and,

1/3 to Donna M. Hunt.

- 7. Pursuant to Schedule "A" of the Trust Agreement, Richard and LaVerne's residence at 1278 Bodie Court, Gardnerville, Nevada, the only remaining asset in the Trust, was intended to be transferred into the Trust.
- 8. The petition is being filed to place the residence at 1278 Bodie Court, Gardnerville, Nevada ("Subject Property") into the Trust pursuant to NRS 163.002 and NRS 164.015.
- 9. The name, age and last known address the beneficiaries of the Trust are as follows:

- 10. There is a reverse mortgage on the Subject Property and Petitioner as Successor Trustee desires to sell the Subject Property to pay the mortgage and save the expenses of keeping the Subject Property.
- 11. To facilitate the sale of the Subject Property, it needs to be transferred into the Trust as provided in Exhibit "A" to the Trust Agreement.
- 12. The Trust Agreement under Paragraph 12.1 provides that the place of execution is the governing law. The Trust was executed in Douglas County, Nevada. Therefore, this Court has jurisdiction over the Trust.

13. Laurence R. Hill requests that the Court enter its order accepting jurisdiction and confirming him as Trustee of the Trust.

- 14. NRS 163.002 AND NRS 164.015 provide that a petition may be brought to obtain an order transferring property into a trust if the Trust Agreement provides that it was the Trustors' intent that the property be placed into the Trust.
- 15. It is, therefore, requested that this Court issue an order transferring the Subject Property into the Trust.

Therefore, based on the foregoing and good cause appearing,

IT IS HEREBY ORDERED that this Court accepts jurisdiction over the Trust and confirming the appointment of Laurence R. Hill as Successor Trustee of the Hill Family Trust dated February 22, 1997.

IT IS HEREBY FURTHER ORDERED that the real property commonly known as 1278 Bodie Court, Gardnerville, Nevada 89410 with APN 1220-16-210-058 is transferred into the HILL FAMILY TRUST dated February 22, 1997, which property is described as follows:

All that real property located in the County of Douglas State of Nevada, more particularly described as:

LOT 20 IN BLOCK B AS SAID LOT AND BLOCK ARE SHOWN ON THE AMENDED MAP OF RANCHOS ESTATES, FILED IN THE OFFICE OF THE COUNTY RECORDER OF DOUGLAS COUNTY, STATE OF NEVADA, ON OCTOBER 30, 1972, AS DOCUMENT NO. 62493.

IT IS HEREBY FURTHER ORDERED that once the transfer has been made to the Trust, Laurence R. Hill as Successor Trust of the Hill Family Trust dated February 22, 1997 may sell the Subject Property without further oversight from this

1	Court, and this matter will be deemed complete without further action.
