GRANT, BARGAIN AND SALE DEED

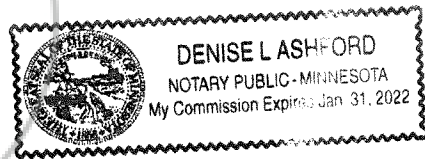

LEGAL DESCRIPTION
