GRANT, BARGAIN AND SALE DEED

THIS DEED is made this ✓ 3 day of ✓ September, 20✓ 21, by and between **Akiko S. All replacements and additions shall also be covered by this Deed. All of the foregoing together with all personal property associated therewith is part of the Property described above.

TITLE TO THE PROPERTY is herein transferred with all tenements, hereditaments and appurtenances thereunto belonging or appertaining, and the reversion and revisions, remainder and remainders, rents, issues and profits thereof.
