THE LAND REFERRED TO HEREIN BELOW IS SITUATED IN THE CITY OF GENOA , COUNTY OF DOUGLAS, STATE OF NEVADA, AND IS DESCRIBED AS FOLLOWS:

Parcel 1:

Parcel 2:
