THEREFORE, based upon the foregoing,

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED AS FOLLOWS:

A lien, on behalf of the NEVADA STATE DIVISION OF HEALTH CARE FINANCING AND POLICY (Nevada Medicaid) in the amount of Fifty-Eight Thousand Two Hundred Seventy-Nine Dollars and Fifty-Seven Cents (\$58,279.57) is hereby imposed against the real property of the undivided estate of DELORIA SKENANDORE, of which
